**AMENDMENTS AND REITERATION OF SCHOOL MEMORANDUM NO. 28 S. 2020  
ENTITLED SCHOOL GUIDELINES ON THE REQUIRED HEALTH STANDARDS**

To: All Teaching and Non-Teaching Personnel  
All Others Concerned

1. Relative to the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments issued by Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases and the Kapasyahan Blg. 2020-12-010 of the Task Force for the Management of Emerging and Re-emerging Infectious Diseases (TF-ERID), this office reiterates the Minimum Health Standards and COVID-19 Preventive and Precautionary Measures that must be observed in this school. It also announces amendments to School Memorandum No. 28 s. 2020 on the **SCHOOL GUIDELINES ON THE REQUIRED HEALTH STANDARDS**.
2. The guidelines must be strictly adhered to in accordance with the IATF and TF-ERID protocols, provisions, with the following amendments:
  - a. No Face Mask and Face Shield, No Entry Policy  
It shall be No Face Mask and Face Shield, No Entry Policy.
  - b. On Infection Control
    1. Personnel, guests, parents are required to accomplish the health declaration form and be evaluated by the health front liners (guards) prior to entry to school.
    2. Thermal scanning is required before entry.
    3. All should be in compliance with physical distancing.
    4. Guards or health front liners are required to wear proper PPE: face mask and face shield.
    5. Provision of foot bath at every entrance.
    6. Children are not allowed to enter the school premises. Only Senior High School learners (15 years old and above) will be allowed to enter the school premises to claim/retrieved the modules provided that parent consent is presented to guard/teacher before entry.
    7. Loitering is not allowed in school.



- c. On Disinfection
  - 1. Regular disinfection of classroom and offices is done every day while General Disinfection is done every Friday from 4:00pm to 5pm.
  - 2. Disinfection of modules is done with the provision of SDM 219 s. 2020.
  - 3. Parent volunteers/Parent Leaders must wear proper PPEs.
- d. Stronger Public Health and Safety Protocols
  - 1. Reorientation of Health and safety Protocols particularly on health front liners, guards, utilities, parent volunteers as well as parents.
  - 2. Maintenance of a Health Information Board in the schools waiting area.
  - 3. Continuous improvement of physical facility specifically the washing area/facility of the classrooms and the school.
- 3. The School' s Health, DRRM and Physical Facility Coordinators shall intensify the monitoring and observance and implementation of health and safety protocols in this school.
- 4. Supplies and other incidental expenses on the implementation of these initiatives shall be charged against MOOE subject to the usual government accounting and auditing rules and regulations.
- 5. Immediate and wide dissemination of this Memorandum is enjoined.
