

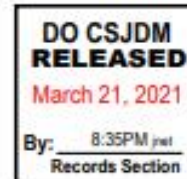

COMPLIANCE WITH MEMORANDUM CIRCULAR NO. 85
OF THE OFFICE OF THE PRESIDENT AND REITERATION OF GUIDELINES
UNDER GENERAL COMMUNITY QUARANTINE (GCQ)

To: SDO Personnel
Public Elementary and Secondary Schoolheads
All Others Concerned

1. Relative to the recommendation of Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases Resolution No. 104, Series of 2021, dated March 20, 2021, and the approval of the Office of the President, Bulacan is placed under General Community Quarantine (GCQ) from March 22, 2021 until April 4, 2021. Further, everyone is enjoined to comply with Memorandum Circular No. 85 of the Office of the President dated March 19, 2021 entitled *Establishing the Operational Capacity to be Observed by Government Agencies and Instrumentalities in Areas Under General Community Quarantine until 04 April 2021, and for Other Purposes.*
2. The operation of the Schools Division Office, schools and Community Learning Centers shall be guided by the additional restriction measures specified in Item B of said Resolution. For emphasis, some measures are hereto restated:
 - a. All mass gatherings including religious gatherings shall be prohibited. The holding of face-to-face meetings are highly discouraged and in the alternative, virtual meetings are highly encouraged.
 - b. Any person below eighteen (18) years old and above sixty-five (65) years old, those with immunodeficiency, comorbidity, or other health risks, and pregnant women, including any persons who reside with the aforementioned, shall be required to remain in their residences at all times, except when indispensable under the circumstances for obtaining essential goods and services, or for work in their respective industries and offices. Persons above sixty-five (65) years old may likewise be allowed for outdoor non-contact sports and other forms of outdoor exercises. Persons With Disability (PWD) may be allowed outdoors for their therapy as well as for outdoor non-contact sports and other forms of outdoor exercises, upon presentation of prescription from their physicians or presentation of PWD ID.
 - c. Visiting persons outside their immediate family or households is strongly discouraged. Even at home, the wearing of masks for the elderly and the vulnerable and for the rest of the household, is strongly advised.

3. Section 2 of MC No. 85 directs agencies, including every office and unit therein, to ensure that delivery of services is not hampered or impaired. Alternative Work Arrangement (AWA) shall still be adopted pursuant to CSC MC No. 10, s. 2020 and CSC MC No. 18, s. 2020.
4. Health precautions and physical distancing measures must be observed at all times not only in the workplace but also during travel/transportation, and at home and private space. Wearing of face masks/shields is strictly advised following the guidelines of the IATF.
5. Immediate and wide dissemination of this Memorandum is highly encouraged.
